



- **1. Acceptance of Terms.** By purchasing products from Indian-American Trade Inc., you agree to be bound by these Terms and Conditions ("Terms"). If you do not agree to all the terms and conditions of this agreement, then you may not make purchases from us.
- 2. Order Acceptance. All orders are subject to acceptance by Indian-American Trade Inc. We reserve the right to accept or reject any order for any reason.
- **3. Pricing.** Prices are as stated on the invoice or quote, subject to change without notice. All prices are exclusive of taxes, shipping, handling, and any other charges, which will be added where applicable.
- **4. Payment Terms.** Payment must be made within 30 days from the date of the delivery. Late payments will incur interest at the rate of 3% per month on the outstanding balance.
- **5. Delivery.** Delivery times are estimates and not guaranteed. We are not liable for delays in shipment or delivery. Title and risk of loss pass to you upon our delivery to the carrier.
- **6. Inspection and Returns.** You must inspect goods upon receipt and notify us of any defects or discrepancies within 7 days of receipt. Returns are accepted only if the goods are defective or not as described and are subject to our return policy. Custom or special order items may not be returnable.

7. Warranty.

We warrant that the products sold are free from defects in material and workmanship under normal use for a period of 1 year from the date of purchase. This warranty does not cover misuse, improper installation, or normal wear and tear.

- **8. Limitation of Liability.** In no event shall Indian-American Trade Inc. be liable for any indirect, incidental, special, or consequential damages arising out of or in connection with the sale or use of any product.
- **9. Governing Law.** These Terms shall be governed by and construed in accordance with the laws of Virginia, without regard to its conflict of law provisions.

- 11. Force Majeure. We shall not be liable for any delay or failure in performance caused by circumstances beyond our reasonable control.
